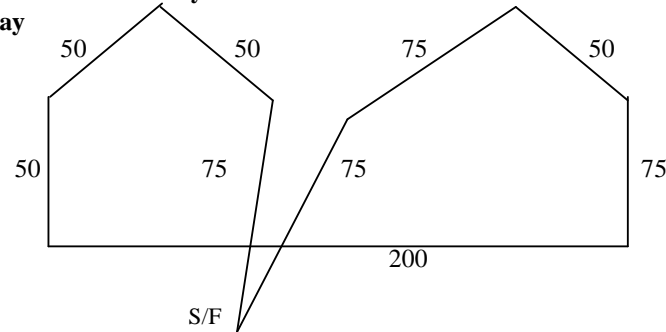

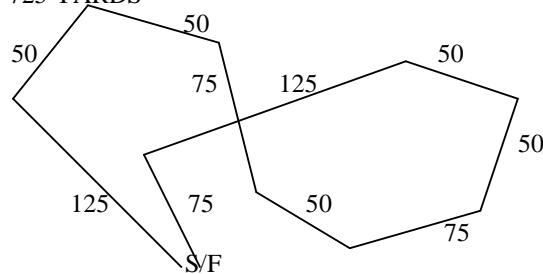
**COURSE PLAN 700 yards**

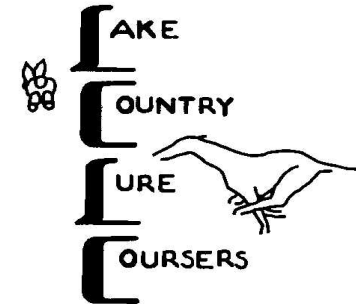

Entries will **NOT** be acknowledged by mail. Late, incomplete, unsigned or conditional entries will not be accepted.

ELIGIBLE BREEDS & REGISTRIES: Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish

Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds, if any, may be entered in the regular stakes. Limited stake breeds, if any, may be entered in Limited Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Silken Windhounds and Portuguese Podengo.

**Hound certification runs will be offered after Best in Field and before Practice.**

**Note: Conformation judging times for Greyhounds, Deerhounds, Ridgebacks and Whippets will not conflict with the field trial. For other breeds, please advise us at or before roll call if you are entered in both events and anticipate a conflict, and we will do the best we can to accommodate you.**

**Please allow extra time and postage for entries to cross the border.** Late, incomplete, unsigned or conditional entries will not be accepted.

**Lunch will NOT be offered at this trial but there is a concession in the park**

All entries in the regular stakes shall be individually registered with the American Kennel Club, the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

**Breed disqualifications apply.**

### STAKES OFFERED

**Open stake:** any eligible sighthound, excluding ASFA Field Champions of record;

**Field Champion stake:** any ASFA Field Champion;

**Veteran stake:** any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Whippets and Rhodesian Ridgebacks, whose age shall be at least seven years.

**Singles stake:** limited to 10 hounds. Singles stake: any eligible sighthound including those disqualified to run in other stakes.

**Limited stake:** any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements.

**Best in Field** will be offered.

### CONDITIONS

- Hounds must be 1 year of age or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified.
- Bitches in season, hounds with breed disqualifications and lame hounds will be excused and the entry fee refunded. Hounds not present at roll call will be scratched.
- Each entry will be examined at inspection for breed disqualifications. Spayed, neutered, cryptorchid, and monorchid hounds (without breed disqualifications) may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Battery powered, continuous loop lure system will be used. Backup equipment will be available. The lure will consist of white plastic strips.
- The course will be reversed for the finals, and again for runoffs and Best of Breed.
- Direction for Best in Field will be at the discretion of the judges.
- Exhibitors are requested to not bring bitches known to be in season to the field.
- A \$5.00 fine will be assessed for any hound loose or interfering with the course in progress.
- A \$20.00 fine will be assessed to any owner not cleaning up after their hound.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.
